# Articles of Incorporation of WE BINETWORKS INC.

#### KNOW ALL PERSONS BY THESE PRESENTS:

That we, the undersigned, have associated ourselves together for the purpose of forming a non-profit corporation under and pursuant to the laws of the State of Arizona, and for that purpose do hereby adopt, execute, and acknowledge the following Articles of Incorporation:

## Article I

The name of the corporation shall be WE BUILD NETWORKS, INC.

## Article II

The objects, purposes and general nature of business in which this corporation shall engage are as follows:

- To increase community awareness of privacy and trustworthiness as aspects of quality for network services and applications.
- 2.To provide a vehicle for community organizations to gain access to the equipment and technical skills needed to improve the privacy and trustworthiness of their own network services and applications.
- 3.To reduce the number of intermediaries needed for community organizations to use network services or applications, and to increase peer relationships among such organizations.

## AND IN ORDER TO FULFILL THESE VARIOUS OBJECTIVES,

- 1.To provide no-cost educational events, open to all, on privacy and trustworthiness in network services and applications.
- 2.To formulate, propose, and implement various programs to improve knowledge, skills, and equipment for network applications and services.
- 3. To acquire, sell, or trade any real and/or personal property required.
- 4. To solicit, collect, and distribute funds and materials.
- 5.To transact any and all lawful business for which non-profit corporations may be incorporated under the laws of the State of Arizona, as they may be amended from time to time.

# Article III

This organization is organized exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. Notwithstanding any other provisions of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under

Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corre any future United States Internal Revenue law), or (b) by a corporatic which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue law).

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth.
